### SMS SUMMIT 2024

In August, our team hosted the annual SMS Summit at the National Academies in Washington, D.C. where attendees got the latest look at ESMS's UI and a demonstration of its capabilities across domains. Panel discussions, Q&A sessions, and breakout sessions were held to share best practices between federal facilities personnel and industry practitioners, where there was great engagement from attendees.

## ESMS DOMAIN STATUS

We are approaching a MVP for the buildings domain, which will finalize core ESMS capabilities. These core requirements are shared across domains, which will create a cascading completion effect and help bring functionality to all domains in ESMS.

### DOMAIN SPOTLIGHT: UTILITIES

After the Utilities CSP in Q3 FY24, six data models have reached a final draft and harmonized with the corresponding SDSFIE gold model for utilities. The SDSFIE program staff are preparing to formalize the new model by having it approved by the joint governing group.

We expect to have the next Utilities CSP meeting scheduled in late Q1 FY25 with a focus on reviewing the new data models.

## REFINING DATA MIGRATION WITH DHA

The SMS team hosted the DHA in Champaign, IL last month at ERDC's Construction Engineering Research Laboratory to coordinate our approach to migrating their data from Builder to ESMS. The two-day session was collaborative in nature, with a variety of specialists from both organizations working in tandem to refine our processes and identify gaps. Our team is currently testing the import function on live data in preparation for initial migration and data parity. This session was an overwhelming success, and will provide a valuable template of detailed questions to address for all Builder stakeholders migrating to ESMS.

## ESMS MOBILE DEVELOPMENT

Funding for the ESMS Mobile development effort was approved in Q4 of FY24. Since then, our development team has been hard at work gathering requirements to execute the mobile application, and we expect to have a minimum viable product in Q3 FY25. The development efforts will also include a QA/QC staging area in the web app where users can validate field data prior to merging into live production data.
